Comments	The company performs random drug testing and reasonable suspicion testing of employees performing covered functions. During 2012 - 6 random PHMSA tests and 1 FMSCA random test were pulled from the Longview district. During 2012 – 175 random drug tests were pulled companywide, consisting of the following types: 46 pre-employment, 125 random, 7 post accidents, 1 unknown and 1 classified as other. 12 DOT random alcohol test were performed. PHMSA pool is tested at 25% annually and FMSCA is tested at 10% annually.

Comments	CNG conducts post accident testing on those who have caused or contributed to the consequences of an accident or incident. All managers or directors recommending post accident testing will confer with the Manager, Human Resources – Robert Harris and the Safety Department.

Comments	<p>The Company provides employees a copy of the Alcohol Misuse Prevention Plan and Anti Drug Plan at the time of hire and when the policy is updated, most recently in March 2013. The hotline numbers are included in the plan and the hotline numbers are also posted on the employee bulletin board. Employees are provided information on the Employee Assistance Plan on a semiannual basis, most recently a brochure on the EAP program was distributed to employees in 2012. Educational information on the Drug and Alcohol program is distributed or discussed annually during safety meetings along with information or updates on the Employee Assistance Program. The US Department of Transportation pamphlet titled “What Employees Need To Know About DOT Drug &amp; Alcohol Training” was distributed in 2010. In 2011 a program was conducted for Longview employees using the pamphlet titled Substance Abuse Training For The Workplace – An Employee Handbook. Post Accident training was conducted for managers during a 2011 Safety &amp; Compliance meeting in Boise Idaho . EAP brochures and postings are distributed to employees semi annually.</p>
